RESTRICTIVE OF HAZARDOUS SUBSTANCES DECLARATION **Updated 1/29/2024**

All Rubberfeet.us parts are Conflict Minerals 3TG, BPA Free RoHS & REACH 3 Compliant. All parts are free of any California PROP 65 warnings. Rubberfeet.us parts are made in the USA. Rubberfeet.us parts are food safe and approved for commercial kitchen use.

Restriction of Hazardous Substances (RoHS III) & Waste Electrical and Electronic Equipment (WEEE), EU Directives CERTIFICATION

In response to your inquiry regarding European Union (EU) RoHS Directive 2015/683/EU (also known as RoHS3) went into effect on June 04, 2015.

EU RoHS specifies maximum levels for the following 10 restricted substances. The first six applied to the original RoHS while the last four were added under [RoHS 3](#), which takes effect July 22, 2019.

- Bis(2-Ethylhexyl) phthalate (DEHP): < 1000 ppm
- Benzyl butyl phthalate (BBP): 1000 ppm
- Dibutyl phthalate (DBP): < 1000 ppm
- Diisobutyl phthalate (DIBP): < 1000 ppm
- Cadmium (Cd): < 1000 ppm
- Lead (Pb): < 1000 ppm
- Mercury (Hg): < 1000 ppm
- Hexavalent Chromium: (Cr VI) < 1000 ppm
- Polybrominated Biphenyls (PBB): < 1000 ppm
- Polybrominated Diphenyl Ethers (PBDE): < 1000 ppm

RoHS 2.0 Directives 2011/65/EU and 2003/11/EC relating to restrictions on the use of certain hazardous substances in electrical and electronic equipment;

Based on our knowledge of the manufacturing and packaging processes and the raw materials used in those processes, none of the restricted chemicals (Cadmium, Lead, Mercury, Hexavalent Chromium, Polybrominated Biphenyls (PBB'S), Polybrominated Diphenyl Ether (BPDE), Diisobutyl phthalate (DIBP), Dibutyl phthalate (DBP), Benzyl butyl phthalate (BBP), Bis(2-Ethylhexyl) phthalate (DEHP)) listed in the directives, are present or exceed ppm levels as required by EU Directives.
